I would like to have the opportunity to continue to be of service to the physicians and patients in District Two and the state of Ohio as an OSMA Delegate. During my term as OSMA President my main initiatives were dealing with Physician Well-Being and OSMA governance.

Addressing the issue of Physician Well-Being began with implementing an OSMA Physician Well-Being Committee composed of physicians and several medical students throughout Ohio. Our committee accomplished the following: development of an OSMA Physician Well-Being resource website, submission of a National Academy of Medicine Commitment Statement, distribution of a survey to hospitals to assess what kind of programs are available for physician wellness, and for the first time, during the 2019 OSMA Educational Symposium the opportunity for a “Physician Well-Being” education track.

Despite all our work on the committee we have more to do, including fulfilling a Physicians Foundation Grant, providing an educational forum and Town Hall discussion surrounding Physician Well-Being in five different Ohio regions. It is key to get the input from physicians throughout the state to share best practices in improving the workforce environment to foster and enhance physician resiliency. We must continue to identify regulatory and legislative burdens on physicians and work to find solutions to resolving those problems.

Thus, it is my hope District Two would support me in returning to my past role as an OSMA District Two Delegate to continue serving the physicians and patients in our District and in Ohio.
