Health Equity and Cultural Competency CME Opportunities

CareSource is partnering with CME Outfitters to create CME education on cultural humility, health equity, trauma and gender informed care, and vaccine equity. In 2023 CareSource plans to release 4 on-demand webcasts for CMEs, 45-60 min in length on average. The center for Medicare & Medicaid Services (CMS) requires Dual-Eligible Special Needs Plans (D-SNPs) and MyCare Plans to provide initial and annual Model of Care (MOC) training to all network and out-of-network providers seen by D-SNP and MyCare members routinely.
