

PerformPlus® Gaps in Care Closure Program



Incentive program for primary care providers

We are excited to announce that on July 1, 2023, primary care providers became eligible for AmeriHealth Caritas Ohio's Gaps in Care Closure Incentive Program. This program will be available for the remainder of 2023.

The program rewards primary care practices for each member attributed to the practice who receives the recommended wellness or preventive care outlined in each of the quality metrics listed here.

Eligible providers will be paid \$30 per gap closure for their attributed members. Eligibility is based on being enrolled in the Ohio CPC program and meeting HEDIS criteria for the quality measures listed.

This year's program will continue to reward providers for improving quality outcomes for our shared member population but will be subject to change depending on gap closure measures and incentives. The Quality Performance component of the Gaps in Care Closure Incentive Program will consist of the following measures:

- Child and Adolescent Well-Care Visits (ages 3 – 11)
- Child and Adolescent Well-Care Visits (ages 12 – 17)
- Child and Adolescent Well-Care Visits (ages 18 – 21)
- Controlling High Blood Pressure
- Hemoglobin A1c Control for Patients With Diabetes — HbA1c Poor Control (> 9.0%)
- Prenatal/Postpartum Care — Timeliness of Prenatal Care
- Prenatal/Postpartum Care — Postpartum Care
- Well-Child Visits in the First 15 Months of Life (six or more visits)
- Follow-Up After Hospitalization for Mental Illness — Seven-Day Follow-Up (ages 18 – 64)
