Biography

Dr. Bastulli received his undergraduate degree from Case Western Reserve University and he obtained his medical degree at the Northeast Ohio Medical University (NEOMED.) He completed his residency at University Hospitals of Cleveland and a fellowship in critical care medicine at Cleveland Clinic. He is board certified in anesthesia and critical care medicine.

Dr. Bastulli has served as the president and managing partner of the Cleveland Anesthesia Group (CAG) for over three decades. CAG has provided anesthesia services to hospitals and ambulatory surgery centers.

Dr. Bastulli served as the president of the St. Vincent Charity Health System medical staff and held administrative and leadership positions within the health system. He served as the chairman of the Academy of Medicine & Northern Ohio (AMCNO) Legislative Committee and as a member of the AMCNO Board of Directors. He also served as the AMCNO president and as a member of the AMCNO foundation board.
